We, the first Elected Trustees have worked tirelessly to bring together your thoughts and aspirations developed over the past three years of the three models and now look forward to eventually realising a representation model that reflects the majority.



Background to Consultation

Ngā Tokorima a Hinemanuhiri Trust is one of 7 Beneficial Entities (Kāhui) of the parent body, Tātau Tātau O Te Wairoa Trust, the Post Settlement Governance Entity (PSGE). In September 2018, Tātau Tātau O Te Wairoa Settlement became law and in November 2018 the Settlement Redress was received.

In 2017 and 2018, members discussed vigorously at many Kāhui meetings how future Trustee representation will be organised. At the July 2018 Kāhui meeting, members agreed that the decision should be voted on by all Adult registered members.

On the 12th of January 2019 at Pakowhai Marae, the initial Trustees, Te Āwhina Carmencita Morrell and Huia Libya Huata declared the establishment of the Ngā Tokorima a Hinemanuhiri Trust for the benefit of the members of the Kāhui. On the 27th of April 2019, the First Elected Trustees were elected into office.

The Trust Deed requires the First Elected Trustees to consult with members on how future Trustees are to be appointed prior to the second AGM (scheduled for January 23, 2021). The consultation period is scheduled from the 25th of September to the 11th of October 2020.

Members will be consulted on three (3) options:


- · General Model From the Adult Members of the Kāhui generally in accordance with this deed; or
- **Marae Model** By each Marae by Adult Members who have indicated that the Marae is their primary Marae on the Kāhui Register; or
- **Hapū Model** By each Hapū by Adult Members who have indicated that the Hapū is their primary Hapū on the Kāhui Register.

After the consultation and from October 23, 2020 you will be sent a final information pack and you will be asked to Vote on **only one** of the above 3 options.

Members have 3 months to consider the options and the outcome of the option which scores the highest votes will determine how future Trustees will be elected.

On pages 7-10 are clarifications of the 3 models and questions for members to consider.

If you are able to attend any one of the roadshow meetings, you will be given the opportunity to ask questions. You will also receive a copy of this booklet. A video of the three models, can also be accessed via Youtube. This video will also be uploaded to our facebook page and website.



DISCUSSION OF REPRESENTATION MODELS

Hapū Model Option

Background

Ngā Tokorima a Hinemanuhiri hapū derive from 'the five (5) children of Hinemanuhiri' being; Tamaterangi, Makoro, Hingaanga, Pūpuni, and Pareroa.

One of the children of Hinemanuhiri, Pūpuni had no issue (children) so there are four (4) tipuna that all Ngā Tokorima o Hinemanuhiri members can trace their whakapapa back to as their principal hapū.

The Principal Hapū of Hinemanuhiri

The four (4) principal hapū of Hinemanuhiri are:

- 1. Ngai Tamaterangi
- 2. Ngāti Mākoro
- 3. Ngāti Hingaanga
- 4. Ngāti Pareroa.

Primary Hapū of Hinemanuhiri

Over the last twenty plus (20+) generations, the four (4) principal hapū have evolved and created five (5) new successive hapū. These "successive hapū" include: Ngāti Mihi, Ngai Tamatea, *Ngāti Hineterā, Ngāti Poa and Ngāti Hinetū. The deed currently makes no distinction between principal and successive hapū and therefore both categories are currently referred to as primary hapū.

The Hapū Model and Governance

For governance in the Hapū Model:

- There would be nine (9) Trustees that represent the nine (9) primary hapū of Ngā Tokorima a Hinemanuhiri.
- The nine (9) hapū of Hinemanuhiri are: Ngai Tamaterangi, Ngāti Mākoro, Ngāti Hingaanga, Ngāti Pareroa, Ngāti Mihi, Ngai Tamatea, *Ngāti Hineterā, Ngāti Poa and Ngāti Hinetū.
- The Trustees are elected by postal vote and must act in the best interests of all hapū.
- A registered adult member may nominate and vote for one (1) Trustee to represent their primary hapū.

Hapū Registration and Database

- Hapū Committees will be established for all nine (9) hapū.
- The central database of Ngā Tokorima a Hinemanuhiri will be strengthened to reflect primary hapū affiliation of members.
- The Trust would support the alignment and reestablishment of primary hapū databases.

How the Hapū Model Takes Effect

- The hapū model will not take effect until each primary hapū has established a Hapū Committee to enable a robust and transparent election process so as to appoint a representative Trustee. The general representative option would stay in place until the hapū model is ready to take effect.
- The general representative option would stay in place until the hapū model is ready to take effect.
- If the hapū model receives the most votes, the Trustees will vary the Trust deed to reflect the hapū model.

Hapū Model Summary

For the Hapū Model:

 Members align to the nine (9) primary hapū being: Ngai Tamaterangi, Ngāti Mākoro, Ngāti Hingaanga, Ngāti Pareroa. Ngāti Mihi, Ngai Tamatea, *Ngāti Hineterā, Ngāti Poa and Ngāti Hinetū.

- 2. There would be nine (9) Trustees for Ngā Tokorima a Hinemanuhuri for a term of three (3) years.
- 3. Trustees must act in the best interests of all hapū, marae and members.
- 4. Members eligible to vote for only one (1) primary hapū.
- 5. Additional work is required by the Trust to strengthen primary hapū databases.
- 6. The current general representative option would stay in place until the hapū model is ready to take effect.

Background

The seven (7) Ngā Tokorima a Hinemanuhiri Marae represented under this model are;

- Rangiāhua Marae
- Arimāwhā Marae
- Rāmoto Kireara Marae
- Pākōwhai Marae
- Hineterā Marae
- Whetu Mārama Mākoro Marae
- Maromāhue Marae

The Marae of Hinemanuhiri

Currently, the Tātau Tātau o Te Wairoa database shows the following Registered Members for Marae within Ngā Tokorima a Hinemanuhiri:

* Hineterā has recently been included as part of the September 5 special resolution and data for Rāmoto Kireara has not yet been captured under the Tātau Tātau o Te Wairoa Trust Database.

The Marae Model and Governance

For governance in the Marae Model:

- There would be seven (7) Trustees that represent the seven (7) Marae of Ngā Tokorima a Hinemanuhiri elected by postal vote.
- The Trustees must act in the best interests of all Marae and members.
- A registered adult member may only nominate and vote for one (1) primary Marae.

Marae Registration and Database

- The central database of Ngā Tokorima a Hinemanuhiri will be re-organised to reflect Marae affiliation of members.
- Further work will be required by the Trust and the respective Marae to strengthen all Marae databases.
- The Trust would support Marae to ensure their registration database is robust and current.
- Hapū connection to the Marae registration and database will continue to be maintained.

How the Marae Model Takes Effect

- The Marae Model will not take effect until each Marae has an established Marae Committee which is able to run a robust and transparent election process to appoint a representative Trustee.
- The general representative option would stay in place until the Marae model is ready to take effect.
- If the Marae model receives the most votes, the Trustees will vary the Trust deed to reflect the Marae model.

Marae Model Summary

For the Marae model:

- Members align to their seven (7) Marae being: Rangiāhua Marae, Arimāwhā Marae, Rāmoto Kireara Marae, Pākōwhai Marae, Hineterā Marae, Whetu Mārama Mākoro Marae, Maromāhue Marae
- 2. There would be seven (7) Trustees for Ngā Tokorima a Hinemanuhuri elected by postal vote. Each Marae entitled to one (1) Trustee representative.
- 3. Trustees must act in the best interests of all Marae, hapū and members.
- 4. Members would be eligible to vote for only one (1) primary Marae.
- 5. The election process for the Marae Model will be by postal vote.
- 6. Additional work is required by the Trust to work with Marae to strengthen their respective Marae databases.
- 7. The current general representative option would stay in place until the Marae model is ready to take effect.

Question

Should members be able to vote for more than one Marae if they can show whakapapa connection to that Marae?

General Model Option

Background

The General Model option is based on the current Trustee representation model of Ngā Tokorima a Hinemanuhiri.

This model is based on each registered adult member (over 18 years of age) having the right to vote for up to seven (7) Trustees to represent member interests on the Trust.

There are currently 1257 eligible adult members registered with the Trust who are entitled to vote.

The General Model and Governance

In the General Model:

- Any registered adult member is able to nominate themselves or another adult member to stand as a Trustee at each election.
- If there are more than seven (7) nominees, then an election must be held.
- If there are less than seven (7) nominees, then those nominees will automatically be elected subject to the Trust's normal eligibility criteria.
- Elections are held every three (3) years.

How the General Model Takes Effect

In the event that the general model option receives the most votes, all future Trustees will be nominated and voted for by registered adult members generally in accordance with the Trust Deed and no variation to the terms of the Trust Deed will be required.

General Model Summary

For the General Model:

- Registered adult members nominate and postal vote the same way as the previous election of 2019 for Ngā Tokorima a Hinemanuhiri.
- 2. In the general model registered adult members have one vote for up to seven (7) nominees.
- 3. There are seven (7) Trustees for Ngā Tokorima a Hinemanuhuri Trust.
- 4. Trustees must act in the best interests of all Ngā Tokorima a Hinemanuhiri members, Marae and Hapū.
- 5. Ongoing work is required by the Trust to manage the membership database.
- 6. No variation of the Trust Deed will be required.

When does consultation close?

The consultation period on the representation models closes on 12 October 2020.

When does voting on the representation models start?

Members will receive notice to commence voting by Friday October 23, 2020. The online and postal voting period will be open for three (3)months - from Friday 23 October 2020 to Friday 22 January 2021.

An information pack on the final options and a voting form will be sent to you. You will also be able to vote in person at the AGM on Saturday 23 January 2021. The main concept for this piece is unity. Ehara taku toa i te toa takitahi engari he toa takitini. Ngā Tamariki: Tamaterangi • Makoro • Hingaanga • Pupuni • Pareroa The tamariki are depicted as manaia figures wrapped around their mother. Hapaitia te ara tika pumau ai te rangatiratanga mo ngā uri whakaheke.

Hinemanuhiri: The centre piece is a moko kauae, a symbol of high status. Tū mai ra Hinemanuhiri hei pou kapura mo te iwi e kuia Rangatira. NgāTokorima a Hinemanuhiri: Together they represent unity and it signifies the triumphs that can be achieved together as one. He waka eke noa.
